#### **Call to Order**

President Zuber called the Meeting to order at 6:33 p.m.

Vice President Hordyk conducted the Pledge of Allegiance

#### **Roll Call**

**3.** Approval of Agenda: Director Franklin motioned to approve the agenda; Director Lopiccolo seconded the motion. Agenda was approved unanimously.

4. Public Comment: Resident Rob Ebbett asked for an update on the grant and the possibility of a bike park.

**5.** Agency Reports: Sgt. Mark James presented there were 279 citations issued during the recent snow play weekend and a total of 198 hours for 25 deputies. In December there were 146 calls for service. Sgt. James also shared that the Board of Supervisors voted to increase the fines for various vehicle related infractions. CHP Officer Mumfry spoke regarding the food vendors along the highway and to call the non-emergency number for service and not post on Facebook etc. Susan Drake from Supervisor Lovingood's office requested volunteers for the new Tourism Marketing District committee.

**6. Consent Calendar:** Director Franklin requested a change in the wording on the Parks and Recreation Coordinator item. Director Schneider motioned to approve the December 3, 2019 minutes for the regular and special meetings with the change in wording. It was seconded by Vice President Hordyk. The minutes were approved unanimously.

**7. General Managers Report:** General Manager Golden thanked Mike Troeger of Mountain Hardware for his generous donation to replace our equipment and presented him with a plaque for his service. Golden also thanked President Zuber for the use of his employees to finish installation of the new computer and Dusty Gabay for her help with the sound system. Golden also reported on a possible issue with the septic system and will be looking into it further.

**8.** December Financial Statements: Director Lopiccolo had a question about the number of election and skate park payments. The most recent payment for the initial election is due in this month.

**9.** Parks and Rec Event Coordinator: General Manager Golden reported that the ad hoc committee met and updated the Job Description as well as the wording for the ad. Golden reported she has 3 resumes that look promising and will be scheduling interviews.

10. Community Resource Guide: The ad hoc committee was unable to meet so this will be tabled until February.

**11. WCSD Hours and Expectation:** President Zuber accepted the hourly report and made no changes to the current hours.

12. Art & Wine Festival: Pat Farrell presented the expectations for a September Art & Wine Festival.

**13. Sound System:** Dusty Gabay presented that we are still having issues with the sound system being adjusted out of specifications. President Zuber directed to get a lock out system to avoid this.

14. Lahontan Water Board: The Board formed an ad hoc committee to call on the water board for more information.

**15. Appropriations Limit:** Steve Kennedy presented on the need to start working on the limit so it can be submitted for voter approval. General Manager Golden will create the spreadsheet for board approval.





# ITEM 11 **BUILDING DOORS:** DISCUSSION AND **POSSIBLE ACTION**

We are currently experiencing trouble with our building doors. The current doors in front of the building are getting old and we are getting alarms notifications on them. This is due to the hardware not locking the doors properly as well as they are just getting old and they are deteriorating. During heavy winds in January, the doors were blown hard enough to sound the alarm even though they were not opened. The emergency exit on the East is also not latching correctly and we have had a few alarm calls on that door. When getting quotes for new doors, I asked for a quote on the West side door as well to maintain a uniform appearance. The quotes are:



Payment for our work is and payable upon completion of the work. The party who requested and authorizes our work shall remain responsible for payment of our invoice regardless of other parties involved (i.e. – insurance company or landlord). We will not invoice a landlord or insurance company unless they were the party which ordered the work with us. We will provide an itemized invoice if requested.

Service rates can vary with the time of day. Our normal business hours are Monday to Friday, 7:30 AM to 4:30 PM. Overtime charges at one and one half our normal rates and apply Monday to Friday, 4:31 PM to 9:00 PM and Saturday 7:30 AM to 4:30 PM. Premium time charges at double our normal rates apply Monday to Friday 9:01 PM to 7:29 AM, Saturday 4:31 PM to 7:30 AM and all day Sunday. Applicable hourly rates shall apply to travel time to and from the job site. A minimum service charge shall apply any time service is requested and a crew is dispatched regardless of the quantity of work performed.

In the event that payment is not made in full when due the billing party, as listed on the front of this sheet, agrees to pay the maximum legal rate of interest from date service was provided. If any party to this contract brings an action or proceeding to enforce the terms hereof or declare rights hereunder, the Prevailing Party (as defined) in any such proceeding, action, or appeal shall be entitled to reasonable attorney fees. Such fees may be awarded in the same suitor recovered in a separate suit, whether or not such action or proceeding is pursued to decision or judgment. The term "Prevailing Party" shall include, without limitation, a party who substantially obtains or defeats the relief sought, as the case may be, whether by compromise, settlement, judgment, or abandonment by the other party of its claims or defenses.

Any controversy or claim arising out of or related to this contract, or the breach thereof, may, at the option of General Door Service, LLC, be settled by arbitration administered by the American Arbitration Association under its Commercial Arbitration Rules, and judgment on the award rendered by the arbitrator(s) may be entered in any court having jurisdiction thereof.






I am starting to work on the dump cards for 2020/2021. There are several costs associated with these as detailed below:

Good Afternoon, Members of the Wrightwood Community Services District Board:

I am writing as a property owner and full-time resident of Wrightwood, with the intention of encouraging the CSD Board to take the lead role in developing an interagency solution to the winter problem that Wrightwood has experienced for decades.

I am communicating with you in writing for two reasons: 1) I am rarely able to attend CSD Board Meetings, and 2) receiving this letter will offer you ample time to consider how best the CSD can proceed.

There have been plenty of meetings in Wrightwood about this topic in past years, but very little appears to have been done, except by volunteers such as CR&R and Mountain Hardware, to address the serious challenges presented by the host of visitors who come to enjoy our region after a significant snowfall. I recognize that the San Bernardino County sheriff's office has also enhanced patrols, but there are limits to what the deputies are able to do or should be asked to do. Perhaps the CSD will take the opportunity to assume a proactive coordinating role with various agencies during the coming year to at least mitigate the problems that we encounter regarding public safety, sanitation, traffic flows, recreation, trespassing, and crime.

A few mornings ago, on January 5, while I was walking my dog near the country club, two vehicles stopped me and the people politely inquired about where they might let their young children play in the snow. I told them that the areas around town were almost all private property and that they were likely to have sheriff's deputies called on them if they played around here. They acted surprised. Then I directed them up the highway to the Table Mountain area and to Inspiration Point. As I continued my walk, it occurred to me that not all snow players are scofflaws or litterbugs, but that most of them are just folks who drove a long way in heavy traffic looking for a safe and free or affordable place to enjoy the beauty and fun of our mountains and snow with their children and to take a few pictures.

Might it be appropriate for our CSD to coordinate with the U.S. Forest Service, the highway departments and sheriff's offices of San Bernardino and Los Angeles Counties, and whatever

other agencies are necessary, to designate a few safe play areas and to make sure that access and parking are plowed and periodically patrolled?

For instance, and please recognize that these are just illustrative ideas that might not be the best ones, what if the following places were designated as Public Snow Play Areas and identified as such on maps, web sites, and electronic highway signs: Grassy Hollow, Inspiration Point, Jackson Lake, the historic outdoor skating rink, Table Mountain Campground, the first part of Wright Mountain Road, the area east of Hwy 2 about half-way between town and Desert Front Road (that has an off-highway parking area), and at least part of the large chain-up area on the west side of Hwy 2 (when chaining up is not occurring there)?

I imagine that, for instance, if the Table Mountain Campground road and campsite parking areas were plowed, there would be quite a bit of parking and public play space for visitors. Similarly, while parking is prohibited along Hwy 2, there is a flat area off of the highway – east of the highway and a little north of Wright Mountain Road - that, if plowed, would provide quite a bit of parking and reasonable access to forest service land for many of our visitors.

While there will always be some careless people who will ignore parking restrictions and who will trespass and leave trash behind, I think that most of our visitors, if given some directions to good access points, would use them rather than driving around our neighborhoods looking for a sledding area in someone's front yard or illegally parking on the highway and creating a significant safety hazard or risking a parking citation.

I am pretty sure that the ideas expressed above wouldn't completely solve our issues, but they could certainly mitigate things a bit and begin providing a constructive response to what has been a problem for decades. Helping our visitors in this way may also reduce the number folks who are angry and/or frustrated because of their negative encounters with a law enforcement representative or landowner. Happy visitors would probably also benefit our village's businesses, so it may be that the CSD will also want to involve the Chamber of Commerce.

There will still be a need for deputy patrols and volunteer cleanups (I'm a member of Wrightwood's Adopt-a-Highway team), but perhaps we can significantly reduce the needed response. I believe that leaving the solution to Mountain High, Mountain Hardware, Adopt-a-Highway, and CR&R is not the right thing for our CSD to do.

As a conversation starter, I posted something on the Wrightwood Facebook page on January 5. I was surprised that my posting received over 150 responses, and 79 comments (all but a couple of them were positive and constructive). You might want to take a look and see what your constituents and voters are saying about this issue.

Thank you for considering my recommendations and for exploring ways that the CSD Board can provide the necessary leadership to proactively and constructively address this matter.








### CA-56 Monitoring Well Location







NITRATE OCCURRENCE			
Anthropogenic Sources	The largest source of anthropogenic nitrate is industrial production via the Haber-Bosch process. The Haber-Bosch process catalyzes atmospheric nitrogen gas with hydrogen to produce ammonia – which can then be further oxidized to produce nitrate. Approximately 3 to 5 percent of the world's natural gas production is consumed in this process, producing approximately 450 million tons of nitrogen fertilizer per year. High concentrations of nitrate are often associated with fertilizer production and application. Fertilizer that is not used by plants can leach into groundwater and ammonia will rapidly convert to nitrate in the presence of oxygen. Other anthropogenic sources of nitrate to groundwater include septic systems, discharges from wastewater and agricultural ponds, leaky sewer lines, manure fertilizer application, and the production of explosives.		
Natural Sources	Nitrogen is an important biologic element and is a required component of amino acids and proteins. Although nitrogen is the most abundant gas in the atmosphere (as N <sub>2</sub> ), it is not easily used by most organisms in this form. N <sub>2</sub> must first be transformed to a more easily utilized compound, such as nitrate, before incorporation into biologic tissue or plant matter. Nitrate is naturally produced from N <sub>2</sub> through biologic fixation and from organic nitrogen through mineralization. Minor amounts may also be produced through oxidation of atmospheric nitrogen by lightening. Some nitrate from these sources may naturally enter groundwater. However, these concentrations are generally low. Nitrate concentrations greater than 10 to 15 mg/L (as NO <sub>3</sub> ) are generally indicative of anthropogenic nitrate sources (Mueiler, 1995).

History of Occurrence	Nitrate is the most common chemical contaminant in the world's groundwater aquifers. The USGS has estimated that nitrate exceeded background concentrations in 65 percent of shallow wells (<100 feet) in agricultural and urban areas. According to 2010, US Geological Survey publication, up to 7% of 2,388 domestic wells sampled in agricultural and urban areas have nitrate levels above the MCL. Concentrations exceeding the MCL were less common in public-supply wells (about 3 percent of 384 wells sampled). In California, multiple areas have elevated levels of nitrate contamination in groundwater including the San Joaquin Valley, Santa Ana Valley, and Salinas basins.
Contaminant Transport Characteristics	Nitrate dissolves rapidly in water and once dissolved is difficult to remove. Some natural degradation (denitrification) can occur under low or no-oxygen groundwater conditions. However, evidence suggests that aquifer-scale denitrification does not occur, and that once nitrate enters groundwater it can remain there for decades.

#### **REMEDIATION & TREATMENT TECHNOLOGIES**

There is no simple way to remove nitrate from water. Boiling, softening, and filtration as a means of purifying water do not reduce nitrate concentrations. The following methods can reduce or remove nitrate:

#### Demineralization

- **Distillation** Removes nitrate and all other minerals from the water. Distillation is one of the most effective types of demineralization. This process involves boiling the water, then collecting and condensing the steam by using a metal coil.
- **Reverse osmosis** Water is placed under pressure and forced through a membrane that filters out minerals and nitrate.

Both distillation and reverse osmosis are costly and require time and energy to operate efficiently. They are low-yield systems, and storage space for treated water is required.

**Ion-exchange -** Water containing nitrate flows through a tank filled with resin beads that are charged with chloride. As the water flows through the tank, the resin takes up the nitrate and exchanges with chloride.

**Electro-dialysis** – Water containing nitrate flows across anion-exchange and cation exchange membranes in a constant electric field. The use of these mono-anion-selective membranes offer additional possibilities of nitrate removal by enabling preferential flow of mono-valent anions (Rozanska A. and J. Wisniewski, 2003).

Other potential options include: phytoremediation and above ground biochemical denitrification.

#### **HEALTH EFFECT INFORMATION**


High levels of nitrate in drinking water are associated with adverse health effects. Domestic well users are encouraged to test their well water regularly for nitrate.

Infants under six months of age have a greater risk of nitrate poisoning, called methemoglobinemia ("blue baby" syndrome). Toxic effects occur when bacteria in the infant's stomach convert nitrate to more toxic nitrite. When nitrite enters the bloodstream, it interferes with the body's ability to carry oxygen to body tissues. Symptoms include shortness of breath and blueness of the skin around the eyes and mouth. Infants with these symptoms need immediate medical care since the condition can lead to coma and eventually death. During pregnancy, it is common for methemoglobin levels of the pregnant woman to increase from normal (where 0.5 to 2.5% of the total hemoglobin is in the form of methemoglobin) to a maximum of 10% in the 30<sup>th</sup> week of pregnancy. The level of methemoglobin declines to a normal level after delivery. Pregnant women are susceptible to methemoglobinemia and should be sure that the nitrate concentrations in their drinking water are at safe levels.

Some scientific studies suggested a linkage between high nitrate levels in drinking water with birth defects and certain types of cancer. However, long-term scientific studies are needed to determine a direct relationship. According to the EPA, long-term exposure to water with high nitrate levels may cause diuresis, increased starchy deposits, and hemorrhaging of the spleen. People with heart or lung diseases are more susceptible to the toxic effects of nitrate than others because of reduced levels of gastric acidity.

#### RESOLUTION NO. 2020-

#### RESOLUTION OF THE BOARD OF DIRECTORS OF THE WRIGHTWOOD COMMUNITY SERVICES DISTRICT CALLING AN ELECTION ON NOVEMBER 3, 2020, TO ESTABLISH AN APPROPRIATIONS LIMIT; ESTABLISHING A DEADLINE DATE FOR RECEIPT OF WRITTEN ARGUMENTS FOR AND AGAINST THE MEASURE; AND REQUESTING CONSOLIDATION WITH ANY AND ALL ELECTIONS TO BE HELD IN THE SAME TERRITORY ON THAT SAME DATE

WHEREAS, the Wrightwood Community Services District ("the District") is a Community Services District located within the Counties of San Bernardino and Los Angeles, and organized and operating pursuant to California Government Code Section 61000 et seq.; and

WHEREAS, pursuant to Resolution No. 3245 of the Local Agency Formation Commission of the County of San Bernardino ("LAFCO") adopted on May 25, 2017, the District is the successor agency to County Service Area 56; and

WHEREAS, Condition No. 12 of LAFCO Resolution No. 3245 expressly states as follows: "Pursuant to the provisions of Government Code Section 56811, the provisional appropriation limit of the Wrightwood CSD shall be set at \$552,129. The permanent appropriation limit shall be established at the first District election held following the first full fiscal year of operation and shall not be considered to be a change in the appropriation limit of the District pursuant to Article XIIIB of the California Constitution;" and

WHEREAS, Section 4 of Article XIIIB of the California Constitution provides that the appropriations limit imposed on the District may be established by the electors of the District, subject to and in conformity with constitutional and statutory voting requirements; and

WHEREAS, the District's revenue from all sources, including current taxes under the provisional appropriations limit set by LAFCO pursuant to Resolution No. 3245 and funds generated by the District from the provision of services, is grossly inadequate for operating and maintaining the District; and

WHEREAS, the District's appropriations limit must be established at a level that would generate sufficient revenue to operate and maintain the District; and

WHEREAS, the District's General Manager has conducted the necessary analysis and calculations in accordance with Article XIIIB of the California Constitution to determine that the District's appropriations limit should be established in the amount of \$\_\_\_\_\_; and

WHEREAS, it is the desire of the District's Board of Directors to conduct an election on November 3, 2020, for the purpose of establishing an appropriations limit for the District, to request consolidation with any and all other elections to be held in the same territory on that same date, and to assist the Counties of San Bernardino and Los Angeles in every way possible to assure consolidation.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the Wrightwood Community Services District as follows:

- 1. An election shall be conducted within the District on November 3, 2020, to submit to the voters a measure establishing an appropriations limit for the District.
- 2. Measure "\_\_\_\_\_" to be submitted to the voters shall be as follows:

Measure "\_\_\_\_\_" shall go into effect only if approved by a majority of the qualified voters voting in an election to be held on November 3, 2020, and shall become effective ten (10) days after the District's Board of Directors has, by Resolution, declared that such Measure was approved by a majority of the voters voting thereon.
- 4. The deadline date of August 1\_, 2020, at 5:00 p.m., is hereby established for receipt of written arguments for or against the Measure. The deadline date of August 2\_, 2020, at 5:00 p.m., is hereby established for the receipt of rebuttal arguments. Written arguments and rebuttals may be submitted by a member of the District's Board of Directors, any voter or bona fide association of voters within the District, or any combination thereof. Written arguments shall not exceed 300 words in length, and

rebuttals shall not exceed 250 words in length. Such arguments and rebuttals shall be filed with the San Bernardino County Registrar of Voters located at 777 E. Rialto Avenue, San Bernardino, California 92415-0770 and the Los Angeles County Registrar of Voters located at

. The written arguments and rebuttals must be accompanied by Statement Form 9600. For information, call: Lori Golden, General Manager of the District, at (760) 220-8378, during regular business hours.

- 5. The San Bernardino County Board of Supervisors and the Los Angeles County Board of Supervisors are hereby requested to order that the election on this Measure be consolidated with any and all elections in the same territory to be conducted on November 3, 2020, and that the San Bernardino County Registrar of Voters and the Los Angeles County Registrar of Voters conduct the election within their respective jurisdictions for the District. The San Bernardino County Registrar of Voters and the Los Angeles County Registrar of Voters are also requested to give the same Measure designation for both elections and that the filing requirements be similarly coordinated. The District shall reimburse the Counties of San Bernardino and Los Angeles for services rendered in connection with the election upon presentation to the District of a properly approved bill. The District shall further assist the Counties of San Bernardino and Los Angeles, as needed, to prepare for and conduct the consolidated election with the District.
- 6. The election will be held and conducted, election officers appointed, voting precincts designated, ballots printed, polls opened and closed, ballots counted and returned, returns canvasses, results declared, certificates of election issued and all of the proceedings incidental to and connected with the election shall be regulated and done in accordance with the provisions of law regulating the election with which the District election is consolidated.
- 7. The Secretary of the District's Board of Directors is hereby instructed to file certified copies of this Resolution with the Clerks of the Boards of Supervisors of San Bernardino County and Los Angeles County, and with the San Bernardino County Registrar of Voters and Los Angeles County Registrar of Voters on or before 5:00 p.m.

## INVESTMENT POLICY: DISCUSSION AND POSSIBLE ACTION



Currently, the bank balance in our accounts with Desert Community/Flagstar Bank are over \$270,000. FDIC insurance has our accounts insured to \$250,000. The amount over the FDIC insurance is collateralized by the bank. This means the bank has funds set aside to insure the rest of our account balance. However, this money is just sitting and not being productive for the WWCSD. I would like to invest some of this balance into Treasury Bills that have staggered maturity dates. This will enable us to manage our cash better while having the money work for us. Treasury bills have maturity dates of 4 weeks, 8 weeks, 13 weeks and 26 weeks.

Prior to doing any type of investment, we need to approve an Investment Policy.

#### <u>RESOLUTION NO. 2020-</u> RESOLUTION OF THE BOARD OF DIRECTORS OF THE WRIGHTWOOD COMMUNITY SERVICES DISTRICT ESTABLISHING ITS INVESTMENT POLICY

#### 1. <u>POLICY</u>

WHEREAS, the Legislature of the State of California has declared that the deposit and investment of public funds by local officials and local agencies is an issue of statewide concern; and

WHEREAS, the legislative body of a local agency may invest monies not required for the immediate necessities of the local agency in accordance with the provisions of California Government Code Sections 53601 and 53635; and

WHEREAS, the Treasurer/General Manager or fiscal officer of the Wrightwood Community Services District ("District") must annually prepare and submit a statement of investment policy and such policy, and any changes thereto, shall be considered by the Board of Directors at a public meeting,

**NOW THEREFORE,** it shall be the policy of the District to invest funds in a manner which will provide the highest investment return with the maximum security while meeting the District's daily cash flow demands and conforming to all statutes governing the investment of District funds.

#### 2. <u>SCOPE</u>

This investment policy applies to all financial assets of the District. These funds are accounted for in the annual District audit.

#### 3. <u>PRUDENCE</u>

Investments shall be made with judgment and care, under circumstances then prevailing, including, but not limited to, the general economic conditions and the anticipated needs of the District, which persons of prudence, discretion and intelligence exercise in the management of their own affairs; not for speculation, but for investment, considering the probable safety of their capital as well as the probable income to be derived. The standard of prudence to be used by investment officials shall be the "prudent investor" standard (California Government Code Section 53600.3) and shall be applied in the context of managing an overall portfolio. Investment officers acting in accordance with written procedures and the investment policy and exercising due diligence shall be relieved of personal responsibility for an individual security's credit risk or market price changes, provided deviations from expectations are reported in a timely fashion and appropriate action is taken to control adverse developments.

#### 4. **OBJECTIVES**

When investing, reinvesting, purchasing, acquiring, exchanging, selling and managing District funds, the primary objectives, in priority order, of the investment activities shall be:

1. Safety: Safety of principal is the foremost objective of the investment program. Investments of the District shall be undertaken in a manner that seeks to ensure the preservation of capital in the overall portfolio. To attain this objective, diversification is required in order that potential losses on individual securities do not exceed the income generated from the remainder of the portfolio.

2. Liquidity: The investment portfolio will remain sufficiently liquid to enable the District to meet all operating requirements which might be reasonably anticipated.

**3. Return on Investments:** The investment portfolio shall be designed with the objective of attaining a market rate of return throughout budgetary and economic cycles, taking into account the investment risk constraints and the cash flow characteristics of the portfolio.

#### 5. <u>DELEGATION OF AUTHORITY</u>

Authority to manage the investment program is derived from California Government Code Sections 53600, et seq. Management responsibility for the investment program is hereby delegated to the Treasurer/General Manager, who, where appropriate, shall establish written procedures for the operation of the investment program consistent with this investment policy. No person may engage in an investment transaction except as provided under the terms of this policy and such procedures that are established by the Treasurer/General Manager. The Treasurer/General Manager shall be responsible for all transactions undertaken and shall establish controls to regulate the activities of subordinate officials. Under the provisions of California Government Code Section 53600.3, the Treasurer/General Manager is a trustee and a fiduciary subject to the prudent investor standard.

#### 6. <u>ETHICS AND CONFLICTS OF INTEREST</u>

Officers and employees involved in the investment process shall refrain from personal business activity that could conflict or appear to conflict with the proper execution of the investment program, or which could impair their ability to make impartial investment decisions.

#### 7. <u>AUTHORIZED FINANCIAL INSTITUTIONS AND DEALERS</u>

The Treasurer/General Manager will maintain a list of financial institutions, selected on the basis of credit worthiness, financial strength, experience and minimal capitalization authorized to provide investment services. In addition, a list will also be maintained of approved security broker/dealers selected by credit worthiness who are authorized to provide investment and financial advisory services in the State of California. No public deposit shall be made except in a qualified public depository as established by state laws. For brokers/dealers of government securities and other investments, the District shall select only broker/dealers who are licensed and in good standing with the California Department of Securities, the Securities and Exchange Commission, the National Association of Securities Dealers or other applicable self-regulatory organizations.

Before engaging in investment transactions with a broker/dealer, the Treasurer/General Manager shall have received from said firm a signed Certification Form. This form shall attest that the individual responsible for the District's account with that firm has reviewed the District's Investment Policy and that the firm understands the policy and intends to present investment recommendations and transactions to the District that are appropriate under the terms and conditions of the Investment Policy.

Where all funds of the District not placed in FDIC-insured accounts are invested through the Local Agency Investment Fund (LAIF), the Treasurer/General Manager need not be concerned with the qualifications of those financial institutions and broker/dealers with whom LAIF transacts business.

#### 8. <u>AUTHORIZED AND SUITABLE INVESTMENTS</u>

The District is empowered by California Government Code Sections 53601 et seq. to invest in the following:

- a. Bonds issued by the District.
- b. United States Treasury Bills, Notes and Bonds (T bills).
- c. Registered state warrants or treasury notes or bonds issued by the State of California.
- d. Registered treasury notes or bonds of any of the other 49 United States in addition to California, including bonds payable solely out of the revenues from a revenue-producing property owned, controlled, or operated by a state or by a department, board, agency, or authority of any of the other 49 United States, in addition to California.
- e. Bonds, notes, warrants or other evidence of debt issued by a local agency within the State of California, including pooled investment accounts sponsored by the State of California, County Treasurer/General Managers, other local agencies or joint powers agencies. The Local Agency Investment Fund (LAIF) is an approved pooled investment account. The Investment Trust of California (CalTrust) is an approved joint powers authority.
- f. Federal agency or United States government-sponsored enterprise obligations, participations, or other instruments, including those issued by, or fully guaranteed as to principal and interest by federal agencies or United States government-sponsored enterprises.

- g. Bankers' acceptances, otherwise known as bills of exchange or time drafts that are drawn on and accepted by a commercial bank. Purchase of bankers' acceptances may not exceed 180 days maturity or 40% of the District's money that may be invested pursuant to this policy. However, no more than 30% of the District's money can be invested in the bankers' acceptances of any single commercial bank.
- h. Commercial paper of "prime" quality of the highest ranking or of the highest letter and number rating as provided for by a nationally recognized statistical-rating organization. The entity that issues the commercial paper shall either be:

(1) organized and operating within the United States, shall have total assets in excess of five hundred million dollars (\$500,000,000), and shall issue debt, other than commercial paper, if any, that is rated "A" or higher by a nationally recognized statistical-rating organization; or

(2) organized within the United States as a special purpose corporation, trust, or limited liability company, have program wide credit enhancements including, but not limited to, overcollateralization, letters of credit, or surety bond, and has commercial paper that is rated "A-1" or higher, or the equivalent, by a nationally recognized statistical-rating organization.

Eligible commercial paper shall have a maximum maturity of 270 days or less. The District shall invest no more than 25 percent of its money in eligible commercial paper. The District shall purchase no more than 10 percent of the outstanding commercial paper of any single corporate issue.

- i. (i) Negotiable certificates of deposit issued by a nationally or state-chartered bank, a savings association or a federal association (as defined by Section 5102 of the Financial Code), a state or federal credit union, or by a state-licensed branch of a foreign bank; and (ii) certificates of deposit at a commercial bank, savings bank, savings and loan association or credit union that uses a private sector entity that assists in the placement of such certificates of deposit. Purchases of negotiable certificates of deposit under subdivision (i) of this subdivision (h) and certificates of deposit under subdivision (ii) of this subdivision (h) may together not exceed 30 percent of the District's money which may be invested pursuant to this policy. The Board of Directors and the Treasurer/General Manager are prohibited from investing District funds, or funds in the District's custody, in negotiable certificates of deposit issued by a state or federal credit union if a member of the Board of Directors, or any person with investment decision making authority within the District also serves on the board of directors, or any committee appointed by the board of directors, or the credit committee or the supervisory committee of the state or federal credit union issuing the negotiable certificates of deposit.
- j. Repurchase/Reverse Repurchase Agreements of any securities authorized by Section 53601. The market value of securities that underlay a repurchase

agreement shall be valued at 102% or greater of the funds borrowed against those securities, and are subject to the special limits and conditions of California Government Code 53601(i).

- k. Medium-term notes, defined as all corporate and depository institution debt securities with a maximum remaining maturity of five years or less, issued by corporations organized and operating within the United States or by depository institutions licensed by the United States or any state and operating within the United States. Notes eligible for investment under this subdivision shall be rated "A" or better by a nationally recognized rating service. Purchases of medium-term notes shall not include other instruments authorized by this policy and may not exceed 30 percent of the District's money which may be invested pursuant to this policy.
- 1. Shares of beneficial interest issued by diversified management companies (mutual funds) investing in the securities and obligations authorized by this policy, and shares in money market mutual funds, subject to the restrictions of Government Code Section 53601(k). The purchase price of investments under this subdivision shall not exceed 20 percent of the District's money that may be invested pursuant to this policy. However, no more than 10 percent of the District's money may be invested in any one mutual fund.
- m. Moneys held by a trustee or fiscal agent and pledged to the payment or security of bonds or other indebtedness, or obligations under a lease, installment sale, or other agreement of a local agency, or certificates of participation in those bonds, indebtedness, or lease installment sale, or other agreements, may be invested in accordance with the statutory provisions governing the issuance of those bonds, indebtedness, or lease installment sale, or other agreement, or to the extent not inconsistent therewith or if there are no specific statutory provisions, in accordance with the ordinance, resolution, indenture, or agreement of the local agency providing for the issuance.
- n. Notes, bonds, or other obligations that are at all times secured by a valid first priority security interest in securities of the types listed by Government Code Section 53651 as eligible securities for the purpose of securing local agency deposits having a market value at least equal to that required by Government Code Section 53652 for the purpose of securing local agency deposits. The securities serving as collateral shall be placed by delivery or book entry into the custody of a trust company or the trust department of a bank which is not affiliated with the issuer of the secured obligation, and the security interest shall be perfected in accordance with the requirements of the Uniform Commercial Code or federal regulations applicable to the types of securities in which the security interest is granted.
- o. Any mortgage passthrough security, collateralized mortgage obligation, mortgage-backed or other pay-through bond, equipment lease-backed certificate,

consumer receivable passthrough certificate, or consumer receivable-backed bond of a maximum of five years maturity. Securities eligible for investment under this subdivision shall be issued by an issuer having a AAA or higher rating for the issuer's debt as provided by a nationally recognized rating service and the securities shall be rated in a rating category of AAA or its equivalent or better by a nationally recognized rating service. Purchase of securities authorized by this subdivision may not exceed 20 percent of the District's money that may be invested pursuant to this policy.

- p. Proposition 1A receivables, as defined in subdivision (a) of Government Code Section 53610.
- q. Any other investment security authorized under the provisions of California Government Code 5922 and 53601.

A summary of the limitations and special conditions that apply to each of the above listed investment securities is attached and is included by reference in this Investment Policy.

Pursuant to Government Code Sections 53601.6 and 53631.5, the District shall not invest any funds covered by this Investment Policy in inverse floaters, range notes, interest-only strips derived from mortgage pools or any investment that may result in a zero interest accrual if held to maturity.

#### 9. <u>COLLATERALIZATION</u>

All certificates of deposits must be collateralized by United States Treasury Obligations. Collateral must be held by a third party trustee and valued on a monthly basis. The percentage of collateralizations on repurchase and reverse agreements will adhere to the amount required under California Government Code 53601(i)(2).

#### 10. <u>SAFEKEEPING AND CUSTODY</u>

All security transactions entered into by the District shall be conducted on delivery-versuspayment (DVP) basis. All securities purchased or acquired shall be delivered to the District by book entry, physical delivery or by third party custodial agreement.

#### 11. **DIVERSIFICATION**

The District will diversify its investments by security type and institution. Assets shall be diversified to eliminate the risk of loss resulting from over concentration of assets in a specific maturity, a specific issuer or a specific class of securities. Diversification strategies shall be determined and revised periodically, if determined necessary to meet District goals. In establishing specific diversification strategies, the following general policies and constraints shall apply:

a. Portfolio maturity dates shall be matched versus liabilities to avoid undue concentration in a specific maturity sector.

- b. Maturities selected shall provide for stability of income and liquidity.
- c. Disbursement and payroll dates shall be covered through maturities of investments, marketable United States Treasury bills or other cash equivalent instruments such as money market mutual funds.

#### 12. <u>REPORTING</u>

The Treasurer/General Manager shall submit an investment report to the Board of Directors at least quarterly. The report shall include a complete description of the portfolio, the type of investments, the issuers, maturity dates, par values and the current market values of each component of the portfolio, including funds managed for District by third party contracted managers. The report will also include the source of the portfolio valuation. If all funds are placed in LAIF, FDIC-insured accounts and/or in a county investment pool, the foregoing report elements may be replaced by copies of the latest statements from such institutions. The report must also include a certification that (1) all investment actions executed since the last report have been made in full compliance with the Investment Policy and, (2) the District will meet its expenditure obligations for the next six months, as required by Government Code Section 53646(b)(2) and (3), respectively. The Treasurer/General Manager shall maintain a complete and timely record of all investment transactions.

#### 13. <u>INVESTMENT POLICY ADOPTION</u>

This Resolution shall supersede all other inconsistent investment policies of the District. This Policy shall be reviewed on an annual basis and modifications must be approved by the Board of Directors.
